To Whom It May Concern:

Your correspondence has been forwarded to my firm for reply.

My client, TruLife Distribution, is currently the victim of a vicious and illegal cyber-attack, whereby the attackers send various email messages demanding endorsements of my client, on various websites, search engines, and social media platforms. The purpose of these attacks is to generate complaints, rather than endorsements, about my client. The complaints made mostly to the social media platforms, result in my clients proper, professional, and lawful advertising and endorsement being taken down because of the illegal promotion. We have been told the illegal promotion is being sent by a competitor who has a history of illegal activities, and an interest in damaging our client's online reputation but decline to name said competitor outside of legal proceedings for liability reasons.

These emails falsely identify employees, and principles of my client, as the senders of the emails, using various illegal computer techniques to impersonate same. Rest assured that these emails, which have been going on in various forms for several months now, result in no beneficial response to my client, and that my client is the victim herein. It is disappointing the number of people who have actually been fooled by this obvious ploy to attack my client and his staff that I have been forced to reply to. By contacting my client, you have assisted the real criminals by doing exactly what the real criminals want, attacking my client, wasting his time and resources, and injuring his reputation. If you are sincerely offended by this activity and actually wish to assist in the prosecution of this case against the real criminals by testifying in court, please forward me your complete name, mailing address, preferred email address, and phone number, along with copies of the full email metadata to my firm and I will add you to the list of potential witnesses willing to testify.

You may also consider filing a complaint with your local government enforcement agencies. The sending of spam of this nature is illegal, and we would be happy to identify the people who we are fairly certain are responsible to law enforcement directly. Regretfully, minor crimes like
